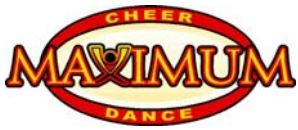

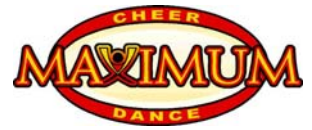

Please read all 2009-2010 General Safety information before signing this contract. Complete all sections of Registration Form/Articles of Understanding and mail with other forms in addition to your registration fees. All forms and fees must be postmarked by the event deadline listed. Registration fees are non-refundable. Mail registration form and payments to:

Paying your Registration Fees

Registration fees and other prepaid items (ticket orders, etc) must be postmarked by the event deadlines. If registering online, the online registration date DOES NOT dictate the payment amount. ONLY the postmark on the envelope is the payment deadline amount. If paying by mail, payments must be made by school or business check, money order or cashiers check. All ticket pre-orders must be paid with certified funds. NO PERSONAL CHECKS WILL BE ACCEPTED.

Returned checks will incur a \$50 fee and the organization will only be allowed to pay with certified funds for future events. Any balances due for any reason will incur a monthly late fee.

If paying by credit or debit card, you must include 2% convenience fee. An online registration must accompany any online payment. To pay by credit card, you must go to the home page of the web site and click on "pay now" at the bottom of the screen. Follow the instructions. If not paid by deadline, the amount due will be the amount of the next payment deadline.

NOTE: Crossover/double duty participants pay full price for their 1st team and the designated discount price for every additional team.

NO refunds of any kind will be given under any circumstances (including teams that drop out after the registration is received). Teams that have paid and do not attend the event for any reason (event date or venue changes, weather related issues or any other competition related problems including cancellation) will be issued a credit upon request for another Maximum Competitions, Inc future event. Please review all deadlines and understand that if payment is not postmarked by the designated deadline, an invoice will be sent and payment must be made upon receipt. NO PAYMENTS OF WILL BE RECEIVED AT THE EVENT. ALL PAYMENTS MUST BE PAID BY THE LATE PAYMENT DEADLINE!

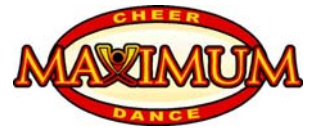

General Event Information and Compliance

- I understand sportsmanship is the very basis for all Maximum Competitions, Inc events. All coaches, participants and spectators must conduct themselves in an appropriate manner. All coaches are responsible for the behavior of their team(s) and spectators. Teams, coaches and spectators representing that team may be disqualified if behavior deemed inappropriate or unsportsmanlike by Maximum Competitions, Inc.
- All music and choreography in my routine is appropriate for all audiences
- I understand all judges decisions are FINAL.
- I understand no food or drinks may be brought into any facility. Concessions will be available all day. Team members and two coaches with coach passes will be admitted. No additional people will be allowed to enter with your team (this includes team moms, trainers, etc.). *All participants must be in competing uniform or team warm up at all times and coaches must display their pass on the provided lanyard.* Please make your coaches, participants and parents aware of these rules.
- I understand all teams must follow the guidelines established for their division. All teams must adhere to age/grade guidelines for the division in which they registered and must be prepared to show proof of age if questioned. No changes in division/level/size are allowed less than 10 days prior to the event.
- I understand Maximum Competitions, Inc reserves the right to add, divide, combine or delete divisions as needed per event to make each event as competitive as possible. Maximum Competitions, Inc reserves the right to provide alternative flooring systems based on the number of registered participants by the event deadline. All efforts will be made to provide the safest possible flooring options available.
- I understand teams, individuals and/or stunt groups may not participate without this form completed and signed. My Medical and Publicity Waivers of all my participants are correct, complete and turned in to the Check-In Officials.
- I understand and have told all my participants, parents, spectators and coaches of ALL rules and guidelines as stated in all Maximum Competitions, Inc. forms and web site and their requirement to follow those rules and guidelines as conditions of participation. Judges and Maximum Competitions, Inc. staff decisions are final. These decisions are not up for review or discussion.

As the Head Coach/Gym Owner, of the above individuals, stunt groups and/or teams, I have read, understand and checked off all the information contained in this 3 page document. I agree that all my coaches, participants, spectators and myself will abide by all rules and regulations of Maximum Competitions, Inc.
